


सार्वजनिक स्वाक्ष नोंदणी Name नागपूर : The name of the Society shall be 'Shree Mahaveer Education Society'.

- 2. **Office** : The registered office of the Society shall be at C/o Pramod Maroti Walmandare, R/o 718, Jai Bhim Nagar, Nagpur.
- 3. **Area** : The area of the Society will be the whole of Union Territory of India.
- 4. **Object** : The objects of the Society are as follows:-



- (1) To promote education and to impart literal social cultural and physical education to the students.
- (2) To start and conduct Pre-primary, primary, secondary schools, Normal Schools, Colleges, Libraries, and other professional & technical educational institutions for the public.
- (3) To take over and manage the educational institutions to affiliate, inspect and guide such professional & technical educational institutions as may apply for it.
- (4) To promote the spirit of research in the sphere of education in cooperation with other institutions and bring about the moral and cultural developments of the students and making them good citizens of the country.
- (5) To develop the spirit of cooperation for the attainment of the aims and objects of the Society among the residents teachers and guardians.

- (6) To develop the spirit of respect and dignity of teaching profession and personal within the Society.
- (7) To buy or otherwise acquire, hold, own, construct take on lease, sale or otherwise deal with lands, buildings, play grounds and other movable and immovable properties conducive and necessary for achieving the objects of the Society.
- (8) To do all such things as are necessary for the attainment of the objects of the Society.
- (9) To establish and run various educational institutions in different faculties i.e. academic, professional, engineering and technical courses for all stages of education such as Nursery, Montesary, Pre-Primary, Primary, High Schools, Colleges, D. Ed., Physical Training Institutes and Training Centers, Agricultural, Medical Colleges, Ayurvedic Colleges, Homeopathy colleges, Naturopathy colleges, Dental colleges, Military Training school for boys and girls etc. for all age groups. To run law colleges, to conduct the courses in the field of social science, social studies and research, humanities. To conduct the courses like B.B.A., M.B.A., M.C.A., B.C.A., M.C.M., B.C.M., Hotel Management and Catering Technology, Aviation Training, B.P.T.H., M.P.T.H., B.Ph.Ed., M.Ph.Ed., B.Ed., M.Ed., B.C.C.A. B.Sc.Nursing & Fire & Safety Colleges, Disaster Management College, Security, Environment training institutions and colleges, Management & Health Science Colleges, A.N.M.Nursing & G.N.M.Nursing Colleges. To start the distance education programmes by affiliating with the other State Universities. To conduct the courses as per the modern requirements and to generate professionals to deal with the ever evolving situations in the various walks of life. To seek affiliation

with other universities whether in India and abroad and to conduct various courses by way of joint collaboration.

- (10) To establish and run physical education training institutes and centers including gymcos, Health clubs and thereby apart various training of National and international sports to youth and to organize various competitions in this field.
- (11) To undertake the programmes for the overall progress for the poor and deserving students, to felicitate meritorious students, to arrange educational tours for them.
- (12) To establish and run libraries in different areas.
- (13) To provide hostel facilities for students of both sexes preferably coming from slum, rural and tribal areas.
- (14) To establish and run Vocational, Professional, Technical, Industrial Training, Audits, Seminar Institutes such as Tailoring, Embroidery, Computer, Book Binding, Craft, Electronics, electrical skin beauty culture and various courses recognized by Vocational and Technical Board of State and Central Govt. and any other trainings essential for the welfare of the youth. To run security training centre.
- (15) To start arts schools colleges for teaching music, singing, dance, painting, arts, craft work and other cultural activities etc. To organize and celebrate national, social, cultural and religious programmes like debate competitions, sports tournaments, seminars, dramas, symposiums, lectures etc. for the psycho-physiological development of the youth. To run competitive exams training centres for exams conducted by central & state Govt.
- (16) To establish and run Shishugruha, Balasadan, Balgram, Child care Centers, Creche Units, Certified Schools, Orphanage Home, Short-stay home, Daycare Centers and

Ashram School for S.C., S.T. N.T., & Backwards classes students.

- (17) To establish and run Girls Hostels, Short-stay homes, and working women Hostels.
- (18) To establish and run educational, training institutes, schools/hostels and rehabilitation centers for physically handicapped, mentally retarded, Deaf, Dumb & Blinds.
- (19) To establish and run old age home and short-stay home for aged.
- (20) To do all efforts for the educational, social, cultural, economic and over all development of women of various field, preferably deserted, social malafied, divorcee, widows, war widows, needy and poor women coming under below poverty line of slum, rural and tribal areas, educate and motivate them for freedom and self dependent with human dignity.
- (21) To do all efforts for development of children from various fields, also development of physically handicapped persons.
- (22) To undertake effective programmes for controlling various types of pollution and thus to create clean and healthy environment to provide relief and essential help to the sufferers at the time of natural calamities.
- (23) To undertake the schemes to under take the schemes for the welfare of the public at large for the Socioeconomic development of the people from slum, rural and tribal area. Thereby to achieve the goal of development and betterment of women, child, physically handicapped etc. For this purpose to undertake the schemes particularly introduced by the Social Welfare Department, Women and Child

Development Department of State and Central Government.

- (24) To adopt villages and implement village upliftment and community development projects.
- (25) To run charitable hospitals/dispensaries/mobile health care units dispensaries and nursing homes preferably for economically weaker sections in slum, rural and tribal areas.
- (26) To organize blood donation camps, health diagnosis camps, eye camp, HIV-AIDS awareness camps, drug abused camps.
- (27) To establish and run blood banks, eye Bank. Treatment-management, guidance centers for Hemophilic, Thalasmia, Bone-marrow failure Sickle-cells disease, HIV/AIDs drug dedications centers.
- (28) To implement various trainings and schemes viz. horticulture, floriculture, social forestry, fisheries and other activities relating to allied agriculture etc for the welfare of youth and entire humanity, purely on non-commercial basis.
- (29) To carry on without any profit motive as a part of social and natural sciences education, research, in the process of overall development of rural residents if Indian nation including reorganization, reconstruction and revival, encouragement and improvement of village agriculture, handicrafts, folk arts, traditional village industries, agro-based in dustiest and for such purpose to train village workers and to help them spread the knowledge amongst the villagers or to employ them for such purpose.

(30) Under this programme, the watershed area wherever available will be surveyed through expert agency of the society on nominal supervision and survey charges. The watershed areas will also be suitably developed by tapping the water resources, conserving available water and increasing the irrigation potential for which the training to the villagers will be given. Afforestation programme will be under taken.

(31) To establish and run the agricultural schools, green farming, natural farming schools and training centers for preservation of the environment. To conduct the training of earthworm farming, farm development programmes, lift irrigation programmes, ground water conservation programmes, fish farming programmes, poultry farms training, goat farms training, pig farms training, cow farm training, training for developing varieties of fruits, vegetables, to conduct all these courses for providing self-employment to the youths from rural and urban area.



(32) To conduct meditation yoga classes through meditation centers with a view to help elevating human life morally and spiritually, to help them adhere to the basic human values viz. liberty equality and fraternity and also to arrange meditation camps.

(33) To start research centers through which facilities for research in social, spiritual fields will be provided.

(34) To provide facilities for cultural exchange programme by study tours and by sending our delegates to foreign countries and inviting foreign delegates to India.

Rules and Regulations

1. ^{अध्यक्ष} ~~सर्वजनिक~~ ^{Memberships} ~~व्यास~~ ^{सोबत} ~~सोबत~~ the Society shall be open to all persons who accept the aims and objects of the Society and agreed to abide by the rules and regulations of the Society and whose applications for memberships are approved by the Governing Council.

2. The members of the Society shall consist of :-

i) Patrons Members :- The persons who shall contribute Rs. 5001 /- in one lump sum or by installments in one year shall be called as patron members. These members shall be the members for life. The Patron members shall have to deposit the amount of contribution as mentioned earlier before the end of the period of one year from the date of enrollment if he desires to deposit the amount of contribution by way of installments. In case of failure to deposit the amount of contribution as mentioned earlier within a period of one year by way of installments, the membership of the concerned person shall stand cancelled on the expiry of the given period and the amount deposited by him till date shall be treated as the amount of donation which shall be non refundable.

ii) Life Members :- The persons who shall contribute Rs. 2500 /- in one lump sum or by installments in one year shall be called as life members. The condition of payment of membership fees applicable to the patron members shall also be applicable to the life members.

iii) Ordinary members :- The persons who shall contribute Rs. 501 /- shall be called as ordinary members.

iv) **Honorary Members** :- The Governing Council of the Society shall have the right to enroll without contribution a persons as a member who in its opinion is a reputed educationalist or otherwise useful to the Society.

3. No person shall be enrolled as member of any class of the membership of the Society unless he is approved by the Governing council of the Society. The Society shall not be bound to disclose the reasons for rejecting the application of any persons to be enrolled as member.
4. Except otherwise provided, all subscriptions are payable in advance i.e. in month of March each year.
5. For the purpose of calculations of subscription part of the month shall be considered as full month.
6. If a member belonging to clause 2(iii) above allows his subscription to fall into arrears for 30 days, he shall be deemed to have discontinued as a member.

All the affairs of the Society shall be managed by the governing council which will be of 7 members, consisting of following office bearers of :

- i) President, ii) Vice-President, iii) Secretary, iv) Joint-Secretary, v) Treasurer, vi) Members - 2.
8. The duration of each Governing Council will be of three years.
9. a) The President and the Secretary shall be elected by the members of the Society from amongst the patron members and life members.
b) Except as otherwise provided all office bearers of the Governing Council will be elected in the General Meeting of

the Society called for this purpose before the end of the 3rd year.

GENERAL COUNCIL

10. The General Council constituting of members of all the clauses of the Society shall meet atleast once in a year and not later than 30th April each year. It shall be desirable for the general council to hold meetings for discussing the subjects in case of emergency or as and when required in the interest of Society.

11. NOTICE AND QUORUM OF GENERAL COUNCIL


The Secretary of the Society shall give atleast 7 days clear notice in writing of the date and time of the meeting and subject to be discussed there at to all the members. The notice of the meeting shall be served to the members through hand delivery. In case the notice could not be served through hand delivery, the same shall be sent under certificate of posting. 2/3rd of the total strength of the members shall form a quorum. No quorum shall be necessary for an adjourned meeting.

12. No member shall be entitled to vote at any meeting who has not been a member of the Society for three months previous to the date of the meeting of has contravened rule 6 above.


13. The following Business shall ordinarily be transacted at the General Meeting.

a) Subject to provision laid down in rule 9 above Election of the office bearers and members of the Governing Council.

- b) To pass the audited balance statement of income and expenditure submitted by the Governing Council.
- c) To read and adopt the auditor's report if any.
- d) To appoint a qualified auditor for the ensuing year who is not a member of the Governing Council.
- e) To sanction after due scrutiny the budget of income and expenditure for the ensuing year submitted by the Governing Council.
- f) To consider any other subject of which due notice has been given under rule above or in the absence of such notice which may be allowed by the Chair.


14. The Governing Council may at any time and shall upon the requisition of two third of enrolled members convene and extra ordinary General Meeting of the Society to consider any subject. At least 7 days notice of such meeting in writing shall be given to all members stating the specific purposes for which the meeting has been called. No other business than the business stated in the notice shall be transacted at such meeting.

15. The meeting of the General Council may take place as and when required for the specific purposes in the interest of the Trust. The rules regarding the quorum of the meeting of General Council shall also be applicable to the extra ordinary general meetings.

16. POWERS OF THE GOVERNING COUNCIL

The Governing Council of the Society shall exercise the following powers:

- a) To employ such teachers and other officers and servants as it may deem fit and proper for the efficient management of the school and other institutions of the Society and may assign to them such duties and delegate to them such powers as it thinks fit.
- b) To receive income and sanction expenditure.
- c) To appoint, fine, suspend, dismiss or otherwise punish any servant in the employment of the Society.
- d) To institute conduct, defend, compromise, refer to arbitration legal proceedings or claims by or against the Society.
- e) To superintend and control the working and internal management of the Institution that may be established supported or affiliated by the Society.
- f) To fill up any vacancy occurring in any manner whatsoever in any membership of the Governing Council, from the members of the Society.
- g) To call the Annual General Meeting of the Society and submit to it the Annual Report together with audited balance sheets and the statement of income and expenditure for the official year ending 31st March.
- h) To frame budget for each official year and submit the same to the general council.
- i) To delegate all or any of its powers to the office bearers.
- j) To co-operate any person for the disposal of any particular matters relating to the object of the Society provided that such co-opted members shall not have powers to vote to a meeting.


- k) To make such rules or bye-laws not in consistent with these rules as may be necessary and expedient for the conduct and proper management of the affairs of the Society.
- l) To apply the funds of the Society to such purposes as they may consider conduct to the objects of the Society.
- m) Not in consistent with the Society Memorandum and these rules for the conduct of accounts the custody control including keeping, checking and passing, to frame such rules and bye-laws from time to time.
- n) Generally to do sanctions or authorize all such matters as may be necessary to be done, sanction or authorize in or about general Business or any affairs not covered by any provisions above.
- o) To give approval for enrolling any one as a member of the Society.



NOTICE AND QUORUM OF GOVERNING COUNCIL MEETING

The notice for the meeting to governing council shall be issued by the Secretary. At least 7 days clear notice shall be given to all the members by way of hand delivery and in case of refusal to receive the notice by hand delivery, then by R.P.A.D. 2/3rd of the total number of members from the governing council shall form the quorum at the meeting. In case the quorum is not formed at the inception of the meeting, the meeting shall be adjourned for half an hour and no quorum shall be required for conducting such adjourned meeting.

18. PROVISIONS FOR LOAN

The Governing Council may by resolutions passed at a meeting specially called for the purpose authorize itself to raise any sum by way of loan or otherwise with or without security for the expenses of the institutions. However, it shall be mandatory to obtain the permission of the Hon'ble Joint Charity Commissioner, Nagpur.

19. MEETINGS OF GOVERNING COUNCIL

The Governing Council shall ordinary meet atleast once in three months. In case of emergency the Secretary may call the emergent governing council meeting. In case of emergency at least 48 hours notice shall be required to be sent to all the members. The rules regarding the notice and quorum shall also be applicable to the emergent governing council meetings.

Any member of the Governing Council who remains absent at three consecutive meetings without any sufficient cause in the opinion of the Governing Council shall be deemed to have resigned the membership of the council provided that, the Secretary draws the attention of such member to this rule before the third meeting of his absence.

21. The Secretary may at any time shall at the requisition of 2/3rd members of the Governing Council call a special meeting of the Governing Council. The notice of such requisition meeting shall be sent as per the rules described hereinbefore.


22. POWERS AND DUTIES OF PRESIDENT

The President shall have the following powers and duties:

a) To preside over all the meetings of the Society.

- h) To grant casual leaves to the servants for not seven days at a time and not more than 15 days in a year and to make arrangements for the performance of their duties during their absence on casual leave.
- i) To purchase furniture books, accessories, apparatus and other things necessary to the extent of Rs.50,000/- within official year and Rs.10,000/- at any time.
- j) To carry on correspondence on behalf of Society.
- k) To maintain accounts and perform any duties including general supervision over the affairs of the Society as may be delegated by the Governing council.
- l) To administer invest and deposit the funds in the hands of the Treasurer in such manner as the Governing council may direct from time to time.


24. The governing council may, further delegate to the Secretary as such of its powers to be exercised in case of emergency as it thinks fit. All orders and actions of the Secretary under this rule shall subject to the confirmation of the Governing Council.

25. RULES FOR REMOVAL OF TRUSTEE OR MEMBER

The Trustee or the member of the Society may be removed from his office for the following reasons :

- a) If such Trustee/member acts in contravention of the interest of the Society.
- b) If such Trustee/member becomes insolvent, lunatic.
- c) If such Trustee/member is convicted for any criminal offence or an offence involving moral turpitude.

- d) If such Trustee/member encroaches upon the property of the Trust or he is found to have misappropriated the amounts of the Society.

26. BANK ACCOUNT

The Bank Account of the Society shall be operated under the joint signature of Secretary and either of the office bearers amongst President and Treasurer.

27. THE FUNDS OF THE SOCIETY



The funds of the Society shall include donations grant periodical subscription and fees of the students. The funds shall also include the government grants for the charitable objects and projects conducted by the Society.

28. These rules shall not be amended added to or abrogated except by the majority of the members present at the meeting of the General body specially convened for the purpose, except during the first three years every right of amendment will be reserved by the Governing Council.

29. All suits and other legal proceedings by and against the Society shall be brought in the name of the secretary of the Society who shall represent the Society in all such suits and proceedings. All other dealings shall be carried on by the Secretary on behalf of the Society.

30. TENDERING AND ACCEPTANCE OF RESIGNATION

Any Trustee from the governing council or the member from the general council may submit his resignation to the Secretary. Such resignation shall be deemed to be accepted only after due consideration and acceptance thereof by the governing council.

The income of the property of the Society when so ever derived shall be applied solely towards the promotion of the objects of the Society as set fourth in the memorandum of the Society and no portion thereof shall be paid or transferred directly or indirectly by way of dividend bonus or otherwise howsoever by way of profits by the members of the Society provided that nothing herein shall prevent payment in good faith or remuneration to any officers or servants of the Society or to any member of the Society or other persons in return of any services actually rendered to the Society not prevent the payment of interest at a rate not exceeding six percent on money borrowed from any member of the Society.

32. If upon the winding up of dissolution of the Society, there remains after the satisfaction of all its debts and liabilities any property whatsoever, the same shall not be paid to or distributed among the members of the Society but shall be given or transferred to some other institution or institutions to be determined by the promoters body at or before the time of dissolution or in default thereof by such a judge of the district as may have or have acquired jurisdiction in matter.

33. True accounts shall be kept of the sums of the money received and expended by the Society and the matter in respect of which such receipts and expenditure takes place, and of the property credits and liabilities of the Society, and subject to any responsible restrictions as to the time and manner of inspecting the same that may be imposed in accordance with the resolution of the Society for the time being shall be opened to the inspection to the members once atleast in every year. The amounts of the Society shall



